TO RECEIVE AN UPDATE FROM THE UPTON ST LEONARDS AMATUER FOOTBALL CLUB (USLAFC)

The Council unanimously agreed to appoint Cllr Keith Pearson as Vice Chairman to the Planning Committee.

5. TO RECEIVE THE FOLLOWING REPORTS:

- **a. County Councillor.** A report was circulated to the Members prior to the meeting, the Chairman detailed the salient points. The Council agreed to send its congratulations to Cllr Sue Williams on her recent appointment as Vice Chair of the County Council.
- **b. District Councillor.** Cllr Keith Pearson reported that during a recent SDC meeting the appointments were made, he also updated the Council on the political makeup of the Council. Finally, he updated the Council on the SDC EV charging scheme.
- c. Council Chairman. Cllr Chrissie Castle updated the Council on a recent meeting with the County Cllr and Highways Stakeholder, in which the ANPRs, drop kerbs and a safe crossing point were discussed.
